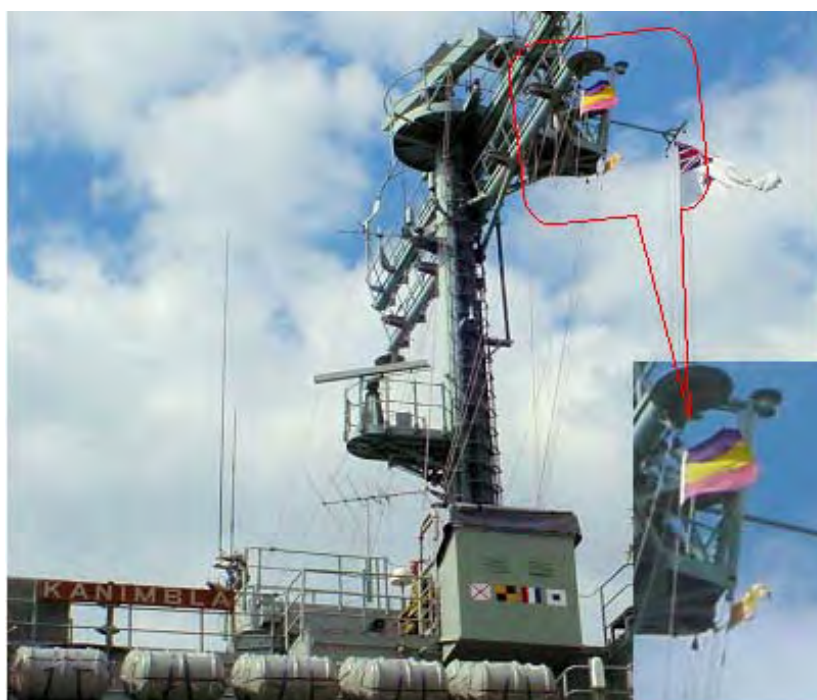

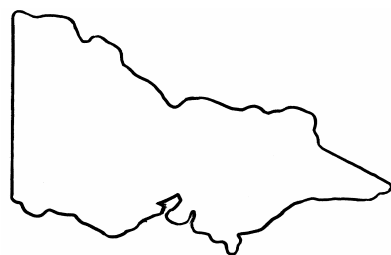

### Bill Hanson

It is my sad duty to announce to the Association the passing of Rev Fr. Bill Hanson on Wednesday 31 May 2006 at Busselton, WA.

Bill was a National Serviceman, born 1945, who served in Vietnam with 1 Armd Sqn Wksp between 29.04.68 and 13.10.68 and then was one of the founding members of 106 Fd Wksp serving between 14.10.68 and 12.11.68.

While Bill was a member of 106 for only a short period, he would have been one of those hard-working soldiers who did their normal job as well as doing the hard yakka getting the Armd Sqn Wksp site area upgraded for the "new" workshop.

When Bill returned to Australia his Vietnam experience moved him to become an Anglican Catholic Priest, his final position was the rector of St Peters Busselton WA. Bill also served as a chaplain for the Western Australian Vietnam Veterans and for the RAEME Association of Western Australia Inc.

Bill had a Heart Transplant about 5 years ago and it was recognised that his service in Vietnam caused the disease that precipitated the Heart transplant. It was during the DVA advocacy work that Bill offered himself as the chaplain for the Association. Our other chaplain is now in the ARA and serves in Townsville. During one of Bill's visits to Perth he told me that the Good Lord found a new Heart for him because He still had work for Bill to do.

Right throughout the recovery stage of his heart transplant, Bill firmly believed this and it helped immeasurably with his recovery.

On a personal note, Bill would visit Clare and I each time he came to Perth for a check up with the Cardiologist. The debates and arguments we had around our kitchen table, particularly about religion, endeared Bill to both of us. At one of our debating sessions, it became so intense that Bill actually forgot to go to the Bishop's home for dinner. Clare and I will miss the camaraderie that we shared with Bill.

He was a gentle man who cared for his fellow man and never had a harsh word for anyone. He often said to Clare and I that when the Lord decided his work was done on earth, He would call Bill home. We are both sure that he received a rousing welcome when he got "Home".

A funeral service for Bill took place at Bunbury Crematorium on Friday 9th of June 2006 at 1400 hours.

## Dennis Oakley



**S/Sgt Dennis Arnold Oakley**, better known to all his friends in the Army as “**Annie.**” Being a fitter - armourer and a sharp shooter he became known to us all in the terms of endearment as “**Annie Oakley**”.

Dennis was born on the 12th April 1930 in Melbourne, Victoria and passed away suddenly on the 7th April 2006 aged 75 and as you will note only 5 days before his 76th birthday.

He commenced his Military Career in the **A.R.A.** on the 7 July 1948 in **RAEME** and was posted to Southern Command Workshop initially, then to 3 Base Wksp Broadmeadows on the 21st September 1953, later to 20 NS Battalion on the 26th March 1956, then Bandianna Area Workshop, 13 August 1956 and finally Pucka Area Workshop on the 3rd September 1958.

Dennis's Employment Duties consisted of: Six months Recruit Training at Pucka, he then went on to qualify as a blacksmith and small arms fitter and that became his trade Posting.

He was Promoted to:

T/Cpl with 20 NS Trg Battalion 22 June 1956  
Cpl also with 20 NS Battalion 10 August 1956  
T/Sgt at Area Wksp Pucka 29 October 1958  
Sgt also at Pucka Area Wksp 1st January 1959.

Dennis discharged on completion of his A.R.A service on the 13th July 1960 as a substantive Sergeant and later joined the CMF (Now Army Reserve)

Dennis loving **RAEME** decided to stay with the Corp and transfer to the CMF and went along and Joined 3 Base Wksp (CMF Component) on the 9th December 1960.

For some reason un-be known to the writer he was enlisted as a Corporal and promoted Sergeant that same day, but only soon after he again was promoted to S/Sgt, possibly he should have marched into the CMF as T/WO 2 as his substantive ARA Rank was Sergeant. However, it was so long ago maybe I could stand corrected.

Once again Dennis in his CMF life supported mostly RAASC units within the Transport Workshops Companies (Now RACT) and they were as follows: 7 Coy RAASC, Coburg, 33 & 15 Tpt Coy RAASC Sth Melbourne and in 1970 he returned to Chapel East St Kilda where he served with the following RAEME units, 105 Fld Wksp & again 3 Base Wksp (CMF Component) towards the end of his career he moved to Gapsted in Victoria finishing his time at Pucka Area Wksp. He discharged in 1974.

Dennis's military career spanned 25 years and even up to his death **RAEME** was never out of his thoughts. He joined the RAEME Association Victoria and was a member for many years and when the occasion arose he came along to various functions especially those that were held in the North East of Victoria in the later years and was thrilled to be amongst his service friends. After his service life Dennis moved from Melbourne and married his charming lady Margaret and they moved to Gapsted later purchasing a small property in Whorouly Victoria and finally moving to Myrtleford where he resided until his passing.

He was a great hobby man and such things as rabbiting & fishing with his friends in Myrtleford were great pass-times for him. In addition Dennis made all sorts of models from beer cans (All Vic Bitter) and some models now grace many of his friends bars and mantel pieces. Later as Dennis became a victim of arthritis he found a new hobby brewing his own beer again he became expert at this. Although Dennis did enjoy his brewing he never missed a visit to his local pub to catch up on all the gossip around town, he played bowls for a while and followed his loved Whorouly football team for many years. During his years at the football club Dennis ran the bar and the story goes that his dry sense of humour and the gags he told during happy Hour bought the locals in each Saturday just to have a laugh with Dennis. Dennis was also a great cook and his Bacon & Eggs skills will be missed by all those friends and relatives that had the pleasure of being catered for by Dennis.

Dennis will be missed by his family & Friends as he was a great example of that Australian Digger.

#### Cause of crash 'medical'

A QUEENSLAND man who died in a motorbike accident near Khancoban on Monday may have come off the road after suffering a medical problem.

The man, David Rolfe, 61, from McDowall in Queensland, came off his motorbike on a bend 2km north of Toomah Dam on the Cabramurra to Khancoban road.

Sen-Constable Geoff McKenzie from Tumbarumba police said because the man was an experienced rider, the bend was not particularly difficult and speed wasn't involved, it was likely the crash was caused by a medical problem.

## Colonel Commandant's Mid Year Report

To say that the last six months have been busy for a number of patriotic members is an understatement. The majority of activities have achieved my stated aim of enhancing mateship, welfare to each other and regaining lost "Corps Ethos" through greater awareness and dissemination of information about Corps activities in the Region. My motto for 2006 has been "*To Establish*", which has already been successfully met in a number of areas.

Firstly, the establishment of an annual Regional RAEME Remembrance Service with the highly successful "Inaugural RAEME Day of Remembrance" simultaneously held in Melbourne, Bandiana and Hobart on Sunday, 29 Jan 06, with over 200 members and their families attending the respective services, despite short notice and high temperatures. The project "*Finding RAEME*" continues to slowly add numbers to the Colonel Commandant's lists, but we still have a long way to go with over 2,000 still MIA. A successful reunion at "The Seymour Club" on 1 Feb 06, stimulated the formation of another motivated steering group to join the one in Bandiana, with both working hard to establish new regional Chapters of the RAV. I am most grateful for the self-sacrifice and support given by Andy Turner and his crew "Up North" and by Dave Maddick and his team in Seymour. Sadly it appears that the formation of a group for RAEME Vietnam Veterans has come to a standstill due to internal differences associated with the previously defunct National Association. Until these issues are resolved, it is not expected that there will be any further movement with this group.

Formal visits to four units over the last six months have established greater liaison and awareness of the current maintenance situation. Visits to JLU (V) at Puckapunyal (formerly PWC) on 21 Feb 06 and Bandiana (formerly 4BWB) on 24 Feb 06 revealed the extent of CSP impact from the early 90s, when it was advised that only 15 ARA RAEME personnel are now responsible for 3<sup>rd</sup> and 4<sup>th</sup> line repairs in Victoria.



Moreover, with nine attached to provide technical support for the School of Artillery, this means that only 6 ARA personnel are supervising contractual maintenance throughout Victoria compared to more than 1,000 in 1988. On 22 Feb 06 a Corps History presentation was given to a number of newly graduated RAEME Officers attending their LOBC Course. The opportunity to meet our future leaders was invaluable to hopefully instill "Esprit de Corps" plus reinforce that the Corps' future was in their hands.

I am grateful to COL Jim Phasey for permitting a visit to DTR-A on 17 Mar 06, as well as supporting the drive to increase Corps Ethos by the appointment on LTCOL Mick Buldo as the new Regional RAEME Rep. A downside to the excellent visit to 26 Tpt Sqn Wksp on 30 Mar 06, accompanied by LTCOL Buldo, was the revelation by CAPT Matt Brodie that this last remaining ARA Land Command unit in Victoria was moving north to Brisbane from mid 2007.

On 19 Mar 06 a Burma railway presentation was given as a prelude to the RAEME Widows Luncheon organised by the RAV at Oakleigh Barracks. The ANZAC pilgrimage to Thailand and Burma enabled wreaths to the 84 AEME POWs, who died during or after construction of the Burma railway, to be formally laid at both ends of the line. On a prorata basis, the loss of life by the Corps was therefore equivalent to that for 8<sup>th</sup> Division Infantry Units. Regrettably, these Corps tributes were the first by a senior RAEME officer, in over 63 years. The honour of laying wreaths was further enhanced by the presence of 84 year old CFN Douglas Brazier (AEME and RAV member) who fought in the Pacific Islands in WW2 and is the last surviving member of his unit.

On 5 May 06 Jeff Bruhn held the annual Mafia Formal Dinner at the Vic Bks SGT's Mess attended by 65 members and guests. Due to my unfortunate absence in Burma, both BRIG David McGahey and LTCOL Mick Buldo confirmed that it had been a very enjoyable night and a rare opportunity to regain past pleasures for former serving members.

A "welcome safely home from Burma" function at home on 21 May 06 was attended by 17 members and their wives or companions, who braved the cold to enjoy friendship mixed with the tastes of Asia provide by Sheila and myself. It also provided key members from different RAEME organisations the opportunity to establish new friendships or renew old ones for future activities. A trip to Townsville on 25-29 May 06 permitted a visit to Billabong Sanctuary to check on the well-being of CPL Soult "Snappa" Crock in her 21<sup>st</sup> year of service in RAEME as official mascot to 102 Fd Wksp (Lt). Re-granting of workshop names in CSSBs has guaranteed her ongoing career. Did anyone sign her up for DFRDB in 1985?

Apart from attending the re-vitalised RAT's Corps Birthday celebrations in Hobart on 11 Dec 06, I have just had the honour to attend the RAT's very successful "Inaugural Mixed Formal Dining -In Night" held at the Claremont RSL on 24 Jun 06. An attendance of 41 from less than 80 members spread throughout Tassie, is exceptional in these days of growing apathy. The tables were decked out at the RSL to a high standard equivalent to any Mess due the efforts of "Pop" Barrett and his "backroom" helpers. After hours of hard work, John "Lurch" Lennox provided fascinating entertainment throughout the night with an impressive lite-pro show of historical RAEME pictures from bygone days in Tasmania.

Ongoing promotion of "**The Craftsman of the Year**" Award over recent months seems to be bearing fruit with indications that a greater number of nominations will be made in 2006 than in the last few years. For example, 2 FSB have already indicated they will be nominating for both ARA and GRES categories.

## THE ROYAL AUSTRALIAN ELECTRICAL AND MECHANICAL ENGINEERS

The vital repair and maintenance role for the Australian Army is [provided](#) by the Royal Australian Electrical and Mechanical Engineers (RAEME).

Although the Corps is “young” it has already developed proud traditions. It is fully combatant and Workshop Units and Corps members have served with distinction during war wherever Australian troops have been involved since the formation of the Corps during World War II. The late Viscount Montgomery of Alamein, in giving praise to the Corps stated:

“They exist to keep the punch in the Army’s fist. They are a new Corps, born in the late war, they have done magnificently and have won their spurs in battle”. The date of the formation of RAEME as a corps was 1 December 1942 however, the evolution of the Corps reaches back into earlier Australian military history and before, even back to earlier armies of England.

With the development of firearms, cannon and mortars the responsibility of Ordnance Officers became more important and their armourers and artificers were tradesmen of particular high skills. Those “craftsmen” started a tradition of skills and pride in their workmanship, which is evident in today’s RAEME soldiers. The name “Craftsman”, a proud and noble designation from the time immemorial, is the rank exclusive to RAEME private soldiers.

From the arrival of the first fleet in 1788 until their withdrawal in 1870, defence of the colonies was entrusted to British troops. Until Federation on 1 January 1901, each of the colonies was responsible for its own defence forces. In Victoria, the Ordnance Commissariat and Transport Corps was formed in 1886 and Richard Harding Esquire, a qualified engineer from England, was appointed the first Inspector of Ordnance Machinery on the 19 September 1888 with the honorary rank of lieutenant and with a staff of 12 Armament Artificers. Present day RAEME professional engineering officers can trace lineage to Richard Harding, the first officer appointed by Australian forces to fill an engineering appointment.

After Federation and the amalgamation of the State Defence Forces, the Ordnance Department of the Commonwealth Military Forces was formed. The Chief Ordnance Officer (COO), a civilian, and civilian storemen were the focal point of Ordnance activity in the military districts. The technical advisor to the COO in each military district was the Ordnance Mechanical Engineer (OME) and in the Army

Headquarters in Melbourne was the Principal Mechanical Engineer (PME) who was technical advisor to the Master General of the Ordnance. Small Ordnance Workshops in each military district were staffed by military members named Australian Army Ordnance Corps (P), (AAOC(P)), and civilian public servants who filled the trade positions of wheelwrights, blacksmiths, saddlers and carpenters.

Artificers were transferred to the Engineering Branch of the Ordnance Department however, those serving with artillery companies or batteries remained attached. The Armament Artificers, known as the “Corps of Armament Artificers” came under the command of the Inspector of Ordnance Machinery. Lieutenant Harding, promoted to Honorary Lieutenant Colonel, was appointed to that position in 1909 and remained such until his retirement in 1925.

In 1914, the Corps of Armament Artificers were mobilized for active service and by the time the war had ended their numbers had increased to 55. Corps members distinguished themselves during the war; many of whom served overseas with Australian Artillery units and three were awarded Military cross for bravery.

Between the wars the Army establishments were reduced. However, after the Munich crisis of 1938, limited expansion of the Army was authorised and the Ordnance Workshops undertook the reconditioning of the Army’s mobilisation stores held by the Ordnance Service. The AAOC(P) personnel augmented by temporary civilian tradesmen, upgraded the equipment predominantly of artillery nature. This included adoption of 6 inch Naval guns for land service and modification of 18 pr and 4.5 inch Howitzer field guns for pneumatic tyred wheels. In 1938 the first intake of Army Apprentices were authorised, serving their time in various Military District Ordnance Workshops.

At the outbreak of the 2<sup>nd</sup> World War in 1939, the responsibilities of the Mechanical Engineering Branch of the AAOC were more limited compared to later as other Corps such as Engineers, Transport and Signals were also responsible for mechanical maintenance. However, as the war continued, the commitments of the AAOC(P) increased dramatically due to the increasing sophistication of the Army’s technical equipment.

The problem was not unique to the Australian Army and in its endeavour to keep pace with the trend towards machine warfare the British Government commissioned a committee to investigate the various aspects for the best use of skilled tradesmen in the

services. The "Beveridge Report" recommended that a new Corps of Electrical and Mechanical Engineers (REME) be formed to assume the responsibilities of the workshop organisation of the Royal Army Ordnance Corps as well as certain repair functions of the Royal Army Signals Corps (RASC) and Royal Engineers (RE). This took place on the 1<sup>st</sup> October 1942.

The British proposal had been studied by the Australian Army, it was accepted in principle and adapted for Australian requirements. General Routine Order (GRO)G465 authorised the formation of the new Corps of Australian Electrical and Mechanical Engineers (AEME) as part of the Master General of the Ordnance Branch.

GRO 0578 ordered the new Corps to take effect in two phases:

Phase 1 of AEME to be the transfer of personnel of the Mechanical Engineering Branch of the AAOC on the 1<sup>st</sup> December 1942; and Phase 2 of AEME to be the transfer of unit maintenance tradesmen on 1<sup>st</sup> May 1943.

Until victory in 1945, AEME units and personnel were involved in all phases of war. They served in Egypt, Palestine, Libya, Cyrenacia, Greece and Crete, Syria, Malaya, New Guinea and South West Pacific.

In recognition of service during the 2<sup>nd</sup> World War a numbers of Corps including AEME were granted the title of "Royal" by King George VI on the 10 November 1948.

The Corps today continues to be responsible for ensuring the Army's equipment operates reliably and efficiently and is expeditiously restored to useful condition after failure or damage.

With rapidly changing technology and ever increasing operational requirements of the battlefield the Corps will continue to have heavy demands placed on it.

The foundations laid by the members of the Corp in its short history provide a sound basis for meeting these future challenges.

## ***"COMPO - Never Too Young"***

Confused about your entitlements or how to claim compensation for your service caused disabilities - then join the long queue!! This article is therefore essential reading to provide a simplified explanation of both *Military* and *Veteran Compensation* entitlements.

**Crucial** It is imperative that all readers realise that you are "**never too young**" to make a claim for compensation or to at least ensure that all service related injuries, diseases or incidents are recorded - at the time of occurrence - especially on your medical records. It is even more advisable these days to maintain your own personal file with copies of all incident reports, routine orders (authorising the participation in civilian and service competitions), as well as copies of all related medical reports. Without such documentation or relevant entries, future claims may be rejected solely due to the lack of supporting evidence on your records, *unless you can produce your own copy*. Unlike the beneficial legislation of the ***Veterans' Entitlement Act (1986)*** - where veterans with operational service are given the "*benefit of the doubt*" for any reasonable assertion, the new 2004 legislation has removed the provision to "**presume**" that the injury, disease or death is service related. Onus is now on the claimant to prove it happened, beyond reasonable doubt.

**Background** On 1 Jul 2004 the Government introduced the ***Military Rehabilitation and Compensation Act 2004*** (commonly called MRCA 04). It's purpose was to create a single, tri-service specific compensation scheme to meet the unique circumstances facing personnel serving in the current and future ADF. MRCA 04 represented the Government's response to the detrimental findings of the Inquiry into the Black Hawk disaster of Jun 96 and the lack of "just" compensation to victims, as a result of the controversial introduction of the Military Compensation Act in 1994. MCA (1994) not only depreciated the prior provisions of ***the Safety Rehabilitation and Compensation Act of 1988 (SRCA (1988))***, but more significantly it totally removed the legislated entitlement of ADF personnel to claim compensation under the "*Eligible Defence Service*" provision of ***Veterans Entitlement Act (1986)***, originally awarded by the Whitlam Government on 7 Dec 72. The fallout from the lesser benefits then available to the victims of the Blackhawk disaster, forced the 1997 Inquiry into Military Compensation, followed by the Tanzer Review in Mar 99. The latter investigated the wide criticism about the adequacy, equity between existing Acts and relevance of the existing compensation arrangements for the ADF in line with modern civilian compensation principles. It recommended the formulation of a single compensation system for the coverage of all types of ADF service and the removal of the dual eligibility under both *Veteran* and *Military Compensation*.

In simple terms, the passing of MRCA 04 by Parliament effectively terminated **any** access to **all prior** forms of *Military* and *Veteran Compensation* to **any person** joining the ADF, or for any injury, disease and death **as of 1 Jul**

**04.** MRCA 04 is largely based on the provisions of *SRCA* (1988), plus key beneficial elements of the *VEA* (1986). In short, although MRCA is “superior” to all previous forms of *Military Compensation*, it is not as good as the *Veterans’ Compensation* under the *VEA* (1986), due to politically imposed cost reducing directives.

**VEA Bonus** MRCA 04 has however, had a significant benefit for anybody who had enlisted in the ADF prior to **7 Apr 1991**, in that it has retrospectively re-granted entitlement to the “*Eligible Defence Service*” provision of the *VEA* (1986) previously removed by *MCA* (1994). In other words, if you enlisted before 7 Apr 91, any service related injuries, diseases or death which occurred before 1 Jul 04, can now also be claimed under the *VEA* (1986).

**Date** In other words, the critical issue is “*the date of injury, onset of disease or resulting death*”. The date will determine which of the above Acts for *Military or Veterans Compensation* is applicable for your claim. Remember, only a claim for clinical worsening or aggravation of a service-related condition sustained **prior to 1 Jul 04**, can be claimed under MRCA 04, **not** the incapacity resulting from the date of clinical onset. As such, a claim for aggravation may be detrimental to those with eligibility under the *VEA* (1986). It is suggested you seek “informed” advice prior to making your “once only offered” election. It can therefore be seen that “**Eligibility**” is a very complex issue and should be discussed with an Ex-Service Organisation (ESO) Pension Officer in your local region, who has undertaken training under the Training Information Program (TIP) sponsored by the Department of Veterans Affairs (DVA).

**Entitlement** In the simplest terms, everybody who served or is currently serving in the ADF, has a right to receive compensation through the “**Military Compensation and Rehabilitation Scheme**” (MCRS) for any condition where liability has been accepted under any form of legislation for *Military Compensation*. However, for those who served prior to 6 Apr 94 and that service has been deemed “*Operational or Peacekeeping*” service, or who served in the ADF from “*7 Dec 72 to 6 Apr 94*” - they have an additional entitlement to claim their disabilities under the *VEA* (1986).

After the introduction of MRCA 04, those who served between “*7 Apr 91 to 30 Jun 04*” have retrospectively eligibility to claim under the *VEA* (1986), but can also claim under *SRCA* (1988) for conditions sustained 7 Apr 91 – 6 Apr 94 and *MCA* (1994) for conditions occurring 7 Apr 94 – 30 Jun 04. From 1 Jul 04 all new injuries, diseases or death can only be claimed against MRCA 04.

**Dual Eligibility** Recapping - all former members who had ADF service after 7 Dec 72 and discharged prior to 6 Apr 94, still have an entitlement to claim any service caused disabilities under **both** the *VEA* (1986) and *SRCA* (1988). This also applies to a dependant in the case of a death. Moreover, those who enlisted prior to 7 Apr 91 and are either still serving or had discharged between **1994 and 30 Jun 04** – now have an entitlement to claim under **both** the *VEA* (1986) and *MCA* (1994).

**Single Eligibility** Any condition or death suffered after **1 Jul 04** can now only be claimed against the single entitlement offered by the new Act (MRCA 04).

**One Benefit** Dual eligibility can be a **trap** to the uninformed. Personnel with such an entitlement may legally claim for the “*same condition*” under both the *VEA* (1986) and *SRCA* (1988), or *MCA* (1994), but any such claim **will be adjusted** to result in the same “total financial” benefit - had the claim been made solely against the *VEA*. In other words, “***you can’t double dip***”. Any lump sum payment made by MCRS will be deducted from the grand “*predicted*” total and your *VEA* disability pension payments will be reduced accordingly to offset monies “*already received*”. Hence the reason why some veterans awarded a disability pension at the Special Rate (commonly called T&PI) under the *VEA*, suddenly find themselves on a **Part** Special Rate Pension, once a lump sum has also been paid out for the same claimed condition/s under MCRS. This could have major financial implications for future livelihood due to the loss of monies resulting from CPI increases on a reduced total. Lump sum payments are practical when funds are immediately required to provide future domestic security to offset reduced earning capability due to physical incapacity.

**Rehabilitation** MRCA 04 is constantly being revised following its formulation over several years (since 2000) through extensive consultation with ESOs and the ADF. As stated, it has taken the most beneficial elements of the *SRCA* (1988) and many, but not all, of the beneficial legislation of the *VEA* (1986). The major difference between the *VEA* and MRCA 04, is that the latter has an increased focus on “**rehabilitation**” for those whose capacity for work is affected by conditions for which liability has been accepted under MRCA. In addition, all members assessed for medical discharge will be individually case-managed through the transition to civilian life. Early feedback on the Transition Management Service (TMS) suggests that this civilianised service is having teething problems. However, this is still a significant development in light of difficulties experienced by many former ADF personnel who were previously medically discharged with little or no assistance after discharged. As such, they had to rely heavily on ESOs and Service Associations for support to adjust to civilian life or claiming for just compensation.

**Payment** It is important to note that MRCA 04 has adopted the *SRCA* model of providing compensation payments, not the *VEA* model of a disability pension; - despite adopting the *VEA* processing system using the objectivity of the Statement of Principles (SOPs) issued by the Repatriation Medical Authority (RMA) to establish the vital linkage between service and the claimed condition. MRCA is therefore based on economic and non-economic loss payments, not on payments to compensate for reduced lifestyle and physical incapacity due to service reasons - even though they may have little effect on a veteran’s ability to work and may not be permanent. Under MRCA, similar non-economic loss payments can be awarded once liability has been accepted for a claim, **but only** after the condition or impairment has been diagnosed to be



permanent and has stabilised to allow determination of the level of compensation. Most importantly, any such determination will be periodically reviewed and may be reduced or lost entirely (due to rehabilitative treatment). Whereas under the VEA (1986), accepted disabilities are not reviewed until a veteran lodges a claim for a new condition or an Application For Increased (AFI) Pension for an accepted disability.

**Notification** Another significant difference is that under MRCA 04, receipt of all claims by MRCS must be notified to the representative appointed by each Service Chief. This is obviously to provide greater visibility of the physical incapacity of all serving ADF personnel, so that individuals are not deployed with unknown claimed disabilities, as previously occurred under VEA (1986) or SRCA (1988).

**Claiming** Terminology has also changed in MRCA 04. Now "Wartime (WW2)" "Operational" and "Peacekeeping/Peacemaking" service have been redefined as "**Warlike**" and "**Non-Warlike**". Moreover "Eligible Defence Service" is now define as "*Peacetime Service*". Consequently, due to the changes in terminology and the complexity of the eligibility criteria for each new type of service, **it is strongly recommended that anybody wishing to make a claim, does not do it by themselves - but seeks professional support through a TIP trained Pensions Officer**. Those serving in Victoria have the ability to visit one of the 23 Veteran Centres, which have been established in this State to assist all serving and former ADF personnel with their claims, regardless of their eligibility to either *Military* or *Veteran Compensation*. Too often, through lack of knowledge, individuals badly "stuff" their own case, making it difficult or even impossible for trained volunteers to rectify. The golden rule is – "**don't do it yourself, seek TIP trained assistance**"

**Reduction** Lastly, should any condition be accepted under VEA (1986), and a disability pension received, once you discharge, your superannuation payment (DFRDB or MSBS) **will have no** affect on your disability pension. Under MCRA 04, once you receive your superannuation payments, any weekly disability payment received will be reduced by 60 percent, as the Government in 2004 deemed that future receipt of both superannuation and disability payments was "*double dipping*".

### CHANGE OF COMMAND IN THE MIDDLE EAST

I am pleased to announce that Brigadier Michael Moon has been appointed as the next Commander of the Australian Forces in the Middle East Area of Operations. He takes over from Brigadier Paul Symon, who has held the appointment since November 2005.

Based in Baghdad, Brigadier Moon is commanding around 1700 Australian Defence Force (ADF) personnel on active service in the Middle East to support Coalition rehabilitation and reconstruction efforts in Iraq and Afghanistan.

Brigadier Moon arrives at a time of considerable growth for Australia's operations in the Middle East. Last week the Prime Minister announced details of the Reconstruction Task Force (RTF) to be deployed to Afghanistan later this year.

The RTF will work on reconstruction and community-based projects as part of Australia's commitment to assisting Afghanistan achieve a stable and secure future. This deployment will take the number of personnel under Brigadier Moon's command to around 2000.

I would also like to take this opportunity to praise Brigadier Paul Symon for his command and leadership over the past six months.

Under Brigadier Symon's leadership, our forces have played a key role in the ongoing training and development of the Iraqi Army in Al Muthanna, where 470 ADF personnel are located.

Brigadier Symon has also overseen the completion of several Civil-Military cooperation programs in Iraq, ranging from the construction of mobile health clinics to the provision of irrigation equipment.

Programs such as this have a lasting, positive effect on the future of Iraq and highlight Australia's ongoing commitment to the Iraqi people. In the Middle East area of operations the ADF continues to provide solid support to the Coalition forces in many ways.

HMAS Ballarat continues to conduct maritime interdiction and maritime protection tasks in the Persian Gulf, protecting assets and installations



that are vital to the reconstruction efforts in Iraq.

C-130 Hercules transport aircraft are maintaining an effective air bridge within the Middle East carrying cargo, passengers and conducting Aero-Medical Evacuations.

Our Maritime Patrol aircraft continue to provide invaluable support operating over the Persian Gulf undertaking intelligence, surveillance and reconnaissance missions

The Force Level Logistics Assets in the Middle East are dealing with the everyday problems of sustaining a large force, ensuring properly equipped and carefully inducted forces come into theatre.

In Southern Afghanistan, the Special Forces Task Group is making a significant contribution to the regions stability. Approximately 200 highly trained troops work closely with Coalition forces and the Afghan National Army, operating in difficult conditions, against a fanatical adversary of anti coalition Militia.

The Australian Aviation Task Group based at Kandahar Airfield in Afghanistan is already receiving high praise from their coalition partners for the professional conduct of the extremely difficult operations which they perform.

The Australian helicopters are providing troop lift capabilities, heavy equipment movement, supply transport and Aero-Medical Evacuation to the Coalition operations.

I have no doubt Brigadier Moon will rise to the challenge of commanding these ADF operations in the Middle East and wish him a safe and fulfilling deployment.

**RUNNING REPAIRS VITAL IN VIETNAM***TORRANCEMENDEZ (Westralian)*

More than ever the effectiveness of combat units depends on a small highly-trained corps who can repair weapons and equipment in the heat of battle.

Don Horsley, formerly of the Royal Australian Electrical and Mechanical Engineers (RAEME), remembers the call he got in the Albert Park barracks in Melbourne in 1965, when he was artificer warrant officer in charge of army spare parts.

"We were to collect all the stores required to keep a field force on the go for 12 months," he said. But neither he nor his colleagues were told the destination was Vietnam.

Spare parts were assembled for aircraft, armoured vehicles, weaponry, communications, cooking equipment and even laundry gear.

"We were given a time limit that was to coincide with the task force leaving Australia in February 1965," he said.

The 1st Battalion Royal Australian Regiment was to be based at Bien Hoa, an air base about 30km east of Saigon (now Ho Chi Min City), where they would support the US 173rd Airborne Brigade, an army unit equipped with helicopters.

"There was a big airfield which we had to protect," Mr Horsley said. "Chinese and Viet Cong surrounded this place and we had to keep it operative."

They circled the airfield with troops to secure it, though mortar attacks peppered the base nightly in an effort to strike one aircraft that might knock out another three in its cluster.

By day, the Australians would join in a hunt of Viet Cong who were well dug-in and used a system of underground tunnels in which they would hide and emerge to launch deadly surprise attacks.

"Our engineers would go in and clear the tunnels and became known as the Tunnel Rats," Mr. Horsley said. American and New Zealand troops also had the Tunnel Rats. "They endured unbelievable conditions like nothing we had ever come up against in warfare before."

Through it all, the reputation of the RAEME was enhanced. "Any unit that

served in Vietnam had nothing but praise for RAEME," Mr Horsley said.

They helped the Australian armed forces relocate their base to Vung Tau, 125km from Saigon, with a forward post at Nui Dat. He recalls that Australian troops were not allowed to take weapons on recreational leave in Saigon, unlike the Americans.

"A lot of the problems the Yanks had was with firearms that went off while people were on leave. We didn't have that problem," he said.

Mr Horsley is from Melbourne and joined the forerunner of the Army Reserves when he was 19 in 1948, before going on to serve in Korea, and embarking on a military career.

He moved to Wanneroo in 1987, partly to be with his late comrade, Dick Pease, after marrying a local girl when widowed.


